

Invitation for Tenders

Contract Title: **CONSTRUCTION AND MECHANISATION OF 30NO. BOREHOLES WATER WITHIN SELECTED COMMUNITIES**

1. The Government of the Republic of Ghana, acting through the **AFADZATO SOUTH DISTRICT ASSEMBLY** (the “Employer”), intends to apply a portion of the **DACF** Funding to eligible payments under a contract for which this Invitation for Tenders (“IFT”) is issued. Any payments made under the proposed contract will be subject, in all respects, to the terms and conditions of the funding and conditions to the disbursement of funding. No party other than the Government and the Employer shall derive any rights from the funding or have any claim to the proceeds of the funding.

2. The Works and the Contract expected to be awarded under this IFT is: **Construct 30no. Boreholes District Wide** and to be completed in **3MONTHS** calendar months.

3. The **AFADZATO SOUTH DISTRICT ASSEMBLY** now invites sealed Tenders (“Tenders”) from eligible and qualified entities or persons (“Tenderers”) to provide the works referenced above..
