

Invitation for Tenders

Contract Title: CHANNELIZATION BY EXCAVATION TO DESIGN CROSS SECTIONS, CONSTRUCTION OF 2NO. FOOT BRIDGES, STONE LINING (80M) AND WEIR WITHIN SELECTED SECTIONS OF NSUKWAO RIVER CHANNEL AT ADA

The Government of the Republic of Ghana, acting through the [NEW JUABEN SOUTH MUNICIPAL ASSEMBLY](#) (the “Employer”), intends to apply a portion of the [Ghana Secondary Cities Support Program](#) Funding to eligible payments under a contract for which this Invitation for Tenders (“IFT”) is issued. Any payments made under the proposed contract will be subject, in all respects, to the terms and conditions of the funding and conditions to the disbursement of funding. No party other than the Government and the Employer shall derive any rights from the funding or have any claim to the proceeds of the funding.
2. The Works and the Contract expected to be awarded under this IFT is: [Channelization by excavation to Design Cross Sections, Stone lining and Construction Of Foot Bridges within selected sections Of Nsukwao River Channel \(LOT 1\)](#) and to be completed in [6 months](#) calendar months.
3. The [NEW JUABEN SOUTH MUNICIPAL ASSEMBLY](#) now invites sealed Tenders (“Tenders”) from eligible and qualified entities or persons (“Tenderers”) to provide the works referenced above..

5. This IFT is open to all eligible and qualified Tenderers who wish to respond to the relevant “Tender Documents”. Qualification requirements are as described in **Section III. Evaluation and Qualification Criteria.**
6. A contractor will be selected under a [Missing](#) through the evaluation procedure which is described in the Tender Documents, in accordance with the Public Procurement Act, 2003 Act 663 which are provided on the PPA website at www.ppaghana.org.
