

Invitation for Tenders

Contract Title:UPGRADE MILLENMUM PARK ROAD PHASE 1 (1.60KM), (3500M), CONSISTING OF 0.6M U-DRAIN 3500M, 0.9M DIAMETER PIPE CULVERT (2NO.), 0.9M U-DRAIN OUTFALL (300M), ROADWORKS (2000M),(SUB-BASE,BASE, PRIMER AND FIRST SEAL)

The Government of the Republic of Ghana, acting through the [Techiman Municipal Assembly](#) (the “Employer”), intends to apply a portion of the UDG Funding to eligible payments under a contract for which this Invitation for Tenders (“IFT”) is issued. Any payments made under the proposed contract will be subject, in all respects, to the terms and conditions of the funding and conditions to the disbursement of funding. No party other than the Government and the Employer shall derive any rights from the funding or have any claim to the proceeds of the funding.
2. The Works and the Contract expected to be awarded under this IFT is: [16. Upgrading of Millenmium Park Road Phase 1 Sub-base, Base, Pimer and First seal](#) and to be completed in 12 calendar months.
3. The [Techiman Municipal Assembly](#) now invites sealed Tenders (“Tenders”) from eligible and qualified entities or persons (“Tenderers”) to provide the works referenced above..

5. This IFT is open to all eligible and qualified Tenderers who wish to respond to the relevant “Tender Documents”. Qualification requirements are as described in **Section III. Evaluation and Qualification Criteria.**
6. A contractor will be selected under a [Missing](#) through the evaluation procedure which is described in the Tender Documents, in accordance with the Public Procurement Act, 2003 Act 663 which are provided on the PPA website at www.ppaghana.org.
