

# Invitation for Tenders

The Government of the Republic of Ghana, acting through the [NKORANZA SOUTH MUNICIPAL ASSEMBLY](#) (the “Employer”), intends to apply a portion of the [Ghana Secondary Cities Support Program \(UDG 4 and 5\)](#) Funding to eligible payments under a contract for which this Invitation for Tenders (“IFT”) is issued. Any payments made under the proposed contract will be subject, in all respects, to the terms and conditions of the funding and conditions to the disbursement of funding. No party other than the Government and the Employer shall derive any rights from the funding or have any claim to the proceeds of the funding.

3. The [NKORANZA SOUTH MUNICIPAL ASSEMBLY](#) now invites sealed Tenders (“Tenders”) from eligible and qualified entities or persons (“Tenderers”) to provide the works referenced above..

5. This IFT is open to all eligible and qualified Tenderers who wish to respond to the relevant “Tender Documents”. Qualification requirements are as described in **Section III. Evaluation and Qualification Criteria.**
