

# Invitation for Tenders

The Government of the Republic of Ghana, acting through the [GUAN DISTRICT ASSEMBLY](#) (the "Employer"), intends to apply a portion of the [DACF-RFG](#) Funding to eligible payments under a contract for which this Invitation for Tenders ("IFT") is issued. Any payments made under the proposed contract will be subject, in all respects, to the terms and conditions of the funding and conditions to the disbursement of funding. No party other than the Government and the Employer shall derive any rights from the funding or have any claim to the proceeds of the funding.
